Fraud Alert: Protect Your Accounts Using Goldmark FCU

There is an increasing number of scams in which scammers pose as reputable organizations (including credit unions, the Internal Revenue Service, utility companies) that try to scare you into giving them your information or money.

These scammers can call/text/email you saying there is a problem with your account, you owe back taxes, or they have detected some type of suspicious activity.

The purpose of these communications is usually to get you to react quickly and give them your financial and/or personal information. They typically request your passwords/PIN/verification codes and/or payment.

Be aware of the following:

- Goldmark FCU will not ask you for your password/PIN/verification code.
- Any unexpected request for sensitive information or immediate payment should be viewed as a major warning sign.
- Always verify suspicious communications or offers by calling Goldmark FCU at one of our verified numbers.

Goldmark FCU continuously monitors fraud trends and sends warnings to its membership regarding possible fraudulent calls/messages/offers; we also assist you in verifying suspicious calls/messages/offers.
